

**INDEMNITY/WAIVER AGREEMENT BETWEEN**

**1. WHEREAS:**

- 1.1 The Visitor is desirous of visiting the Synagogue Church of All Nations situated at No. 1, Irefin Street, Ikotun, Lagos Nigeria on a religious tour and for religious purposes and has forwarded necessary application to the Synagogue Church of All Nations in respect of the proposed visit.
- 1.2 The Visitor has requested the Group Co-ordinator/s to assist and facilitate the Visitor's application to Synagogue Church of All Nations.
- 1.3 The Group Co-ordinator/s is an independent person assisting the Visitor for the purpose of facilitating as well as coordinating the Visitor's application and eventual visit to Synagogue Church of All Nations on religious tour.
- 1.4 The Group Co-ordinator/s has agreed to assist, facilitate and ultimately co-ordinate the visit to Synagogue Church of All Nations on the terms and conditions set out hereunder.
- 1.5 The Visitor has voluntarily agreed that the terms and conditions hereunder spelt out govern the Visitor's application, the co-ordination of the Visitor's application and visit to Synagogue Church of All Nations and the Visitor's eventual visit to Synagogue Church of All Nations.

**2. NOW THIS AGREEMENT WITNESS AS FOLLOWS:**

**IN PURSUANCE** of this agreement and in consideration of the Group Co-ordinator/s assisting as Co-ordinator/s of the afore stated visit, the Visitor hereby agrees with the Group Co-ordinator/s that the Visitor's application to visit the Synagogue Church of All Nations on a religious tour be facilitated and coordinated on the following terms and conditions:

- 2.1 That the Visitor's application to visit Synagogue Church of All Nations on religious tour/visit has been made voluntarily to Synagogue Church of All Nations through the Group Co-ordinator/s.
- 2.2 That the terms and conditions governing the making, processing of the Visitor's application and the co-ordination of the Visitor's eventual visit to Synagogue Church of All Nations have been duly brought to the notice of the Visitor.
- 2.3 The Visitor has agreed to be bound by the said terms and conditions.
- 2.4 We / I acknowledge that this is an individual application made voluntarily by myself to the Co-ordinator/s acting merely as Co-ordinator/s and facilitators assisting with my application to travel to The Synagogue, Church Of All Nations ("The SCOAN");

- 2.5 We / I release The SCOAN, Emmanuel TV, its directors, trustees, officers, employees, volunteers invitees, agents, contractors, successors and assigns (herein referred to as "The SCOAN/ Emmanuel TV") and Co-ordinator/s from any claims of any kind which may result from any accident, injury damage, loss or death that may occur while on the tour to The SCOAN/ Emmanuel TV. We / I am aware of our/my rights in this regard including the implications thereof and nevertheless release them herewith;
- 2.6 We / I acknowledge and declare that we/ I am aware of the following facts and that we / I agree to the following terms and conditions including the aforesaid release.

### **3. LIABILITY**

The SCOAN / Emmanuel TV, all persons, parties or organisations acting on their behalf and/or in collaboration with them and all group leaders (hereinafter referred to as "the organising Co-ordinator/s and facilitators") give notice that in regard to the following:

- 3.1 In obtaining the issue of any ticket or coupon, on making any arrangement for transport or conveyance, or for accommodation, the Co-ordinator/s acting as Co-ordinator/s and facilitators only and shall not be liable as principals.
- 3.2 The Co-ordinator/s shall be entitled to make any arrangements for the issue of any ticket or coupon or for the transport or for conveyance or for accommodation as they in their entire discretion may deem advisable.
- 3.3 We / I undertake to abide and comply by all the rules and regulations of The SCOAN/Emmanuel TV in existence at any time of our/my stay at The SCOAN.
- 3.4 The SCOAN / Emmanuel TV and/or the Co-ordinator/s as fully described above shall not be liable in any circumstance whatsoever whether in contract or deficit for any damage, injury, death, loss, delay or inconvenience of any sort whatsoever which may be caused to any passenger whilst on tour or journey or for any alleged failure by the Co-ordinator/s to make satisfactory or any arrangements whether caused through the act or default of any of the volunteers/employees, Co-ordinator/s or sub-contractors of the Co-ordinator/s.
- 3.5 We / I agree that our/my heirs shall indemnify The SCOAN/Emmanuel TV and/or the Co-ordinator/s as fully described above and agree that our / my heirs, executors, administrators and/or assignees shall indemnify the SCOAN / Emmanuel TV and/or Co-ordinator/s from and against any cause whatsoever to any person who may make a claim against the Co-ordinator/s whether for loss or damages to property in the custody of a passenger whether or not such claim is based on the negligence of the Co-ordinator/s, its volunteers or subcontractors.
- 3.6 All arrangements are subject to the law of the country where the conveyance or accommodation or other service is to be provided.

### **4. INTERVIEWS**

Attending an interview does not automatically mean that we/ I will travel to The SCOAN and hereby agree that no expectation to travel is in any way established.

### **5. FOREIGN EXCHANGE**

- 5.1 We / I hereby give permission to the Co-ordinator/s to obtain 800USD at the current exchange rate at the time of travelling for my dormitory accommodation in Lagos. Alternatively, the Co-ordinator/s can obtain 4000USD per private room. We/ I acknowledge the fact that we/ I know that private rooms are subject to availability.
- 5.2 The preferred currency at The SCOAN is US dollars dated from the year 2006 and more recent. Traveller's cheques, credit cards or any other form of payment is not accepted.
- 5.3 There are no ATMs on The SCOAN premises.

**6. FLIGHT DETAILS AND TRAVEL DATES**

- 6.1 We / I agree to travel with the airline secured by the Co-ordinator/s for the group.
- 6.2 Flight dates are subject to airline seating availability.
- 6.3 Attention is drawn to the frequency of changes in official timetables and passengers are urged to verify themselves of any times of departure shown in any program or itinerary.
- 6.4 The Group Co-ordinator/s are not responsible for overbooking by airlines resulting in clients being denied boarding. It is the airline's responsibility to re-route clients on alternative routes at the airline's expense provided clients check in on time.

**7. HEALTH CONDITION**

- 7.1 If there is any change in our/my health condition between the day of the interviews and the day of departure to Lagos, we/I will inform the Co-ordinator/s immediately.
- 7.2 We/I am medically capable to climb the stairs of a five-story building without assistance and move around without assistance. We/ I am aware of the fact that the accommodation, dining room and lecture hall are situated in the above-mentioned building and that there are no lifts or escalators available.
- 7.3 We/I do not have any external open cancer wounds or any other open wounds, nor am I/we making use of dialysis bags.
- 7.4 I will notify the Co-ordinator/s of any sickness and will e-mail a COPY of our/my recent, original medical report to the Co-ordinator/s without delay.
- 7.5 We/I must be in possession of an English, original medical certificate made out in our/my name which states my problem/s or sickness/es, my blood pressure reading and blood sugar levels. This document must be stamped and signed by a medical doctor on an official doctor's letterhead.
- 7.6 We/I agree that we/I will receive a placard/poster stating our/my problem which will be openly displayed; we/ I will be filmed by camera with the possibility of featuring in one of the future healing videos.
- 7.7 We/I am aware that no one will be able to be in the healing line without an original report that meets the above-mentioned requirements.

**8. TRAVEL DOCUMENTS**

We/I am aware that we/ I need the following documents as part of our/my application process:

- 8.1 A South African passport valid for at least 8 months from time of the interviews.
- 8.2 Yellow Fever Vaccination card issued at least 10 days before the travel date. This will be required to pass through the immigration in Nigeria and South Africa.
- 8.3 A Nigerian Visa (the Co-ordinator/s will assist in the application process of your Visa).
- 8.4 We/I am aware of the requirements needed for travelling with children under 18 years of age and I am familiar with the new SA Immigration Regulations that will be effective 01 June 2015. Applicable travelers will be asked to produce the required documentation at check-in for each flight.

**9. INSURANCE**

- 9.1 Passengers are reminded that luggage or personal property taken on tour is at owners' own risk and passengers themselves are advised to insure it.
- 9.2 Travel insurance is compulsory for each individual travelling (the Co-ordinator/s will assist with the obtaining of such insurance prior to departure).

**10. ALCOHOL CONSUMPTION, SMOKING AND DRUGS**

- 10.1 We/I declare that we/I will not consume alcohol or any illegal drugs during the flight or during our/my stay at The SCOAN.
- 10.2 We/I take note of the fact that there are no smoking facilities nor a smoking room available as smoking is strictly prohibited during the full time of our/my stay at The SCOAN.

**11. COSTS AND EXPENSES INCURRED**

- 11.1 If for any reason our/my visa gets rejected or delayed due to a reason undisclosed to us/me or beyond control, we/I will remain responsible for any costs incurred (i.e. airline tickets, travel expenses and visa costs etc.).
- 11.2 We/I acknowledge that airline tickets booked and paid are non-refundable.
- 11.3 We/I hereby take responsibility to cover all costs the Co-ordinator/s may incur with our/my application regardless of whether we/ I travel or not, for assisting us/me in the facilitation of this request.
- 11.4 We/I acknowledge that there are mainly three variables that influence the price of the package to travel namely:
  - 11.4.1 Exchange rate of the USD to ZAR for our/my accommodation.
  - 11.4.2 Visa costs (the Co-ordinator/s use visa agents & do not submit visa applications themselves).
  - 11.4.3 Airline tickets and availability (December is very high demand).
- 11.5 All prices are ex departure point indicated in the tour program and based on prices and rates or exchange ruling at the time of preparation of the document in which the quotation is made and are subject to increase without notice. All prices quoted are per person.
- 11.6 Courier or representatives have no authority or permission to refund any monies paid or give any right to claim a refund from the Co-ordinator/s;
- 11.7 The Co-ordinator/s cannot be held responsible for the obtaining of refunds on lost or unused tickets, coupons or vouchers, although every effort will be made to claim settlement on behalf of passengers.
- 11.8 Payment will be required for children travelling with their parents.
- 11.9 Only Electronic Payments (EFT) will be accepted unless otherwise agreed with the Co-ordinator/s.

**12. ACCOMMODATION**

- 12.1 We / I acknowledge that the duration of our/my stay in the SCOAN will be approximately seven days (depending on airline availability).
- 12.2 Should we/ I want to extend our/my stay we/I will need to wait for confirmation from The SCOAN and our/my Co-ordinator/s. We/I will take full responsibility for any cost implications and arrangement for the accommodation as well as any ticket change costs.
- 12.3 The Co-ordinator/s reserve the right to change the order or the tour according to availability of accommodation.

**13. CANCELLATION**

- 13.1 The Co-ordinator/s reserve the right to cancel or abandon the tour. In such event any monies paid will be refunded, less any expenses, disbursements or other commitments incurred on behalf of the passengers, and in such event no further or other liabilities whatsoever will be accepted by the Co-ordinator/s. The right is further reserved to modify the tour in any way the Co-ordinator/s deems advisable. In this event, the projected tour will not be proceeded with unless a minimum number of passengers (at the discretion of the Co-ordinator/s) participate.
- 13.2 A written notice is required in the event of an applicant cancelling/withdrawing from the trip. Passengers deviating from the tour, or leaving the tour for any reason, will be responsible for any costs.
- 13.3 Visas and tickets already issued are not refundable.

**14. INCLUDED IN TOUR**

We/I acknowledge the following:

- 14.1 Transport: Economy class air travel from Johannesburg to Lagos and return.
- 14.2 Accommodation: At The SCOAN in a standard dormitory or private room (if available and at additional cost).
- 14.3 Meals: we/I will receive three meals per day at The SCOAN.
- 14.4 On arrival transportation from the Murtala Muhammed International airport in Lagos to The SCOAN and back again on the day of departure.

**15. EXCLUDED IN TOUR**

We/I acknowledge the following:

- 15.1 Transportation to and from OR Tambo international airport.
- 15.2 Any passport change, valet and chamber maid services or any items of a personal nature and any services not specifically mentioned above.
- 15.3 Passport charges, deposit and cancellation insurance, luggage insurance, or any items of personal nature and any services not specifically mentioned above and not included with the exception of personal travel insurance which is compulsory.

**16. PACKING GUIDELINES**

- 16.1 Below is a list of some important items to remember to pack in order to make your visit as comfortable as possible.
- 16.2 Light blanket, (pillow, pillow case and bed sheet will be provided).
- 16.3 Bath towel and toiletries (e.g. Soap, shampoo, toothbrush, toothpaste etc.)
- 16.4 Comfortable shoes (A tour of the church will be conducted, and you will be required to climb some stairs to your dining area).
- 16.5 Bible, notebook and pens as you will be watching various teaching videos of the man of God, Prophet TB Joshua.
- 16.6 SIM cards and wireless vouchers will be available from the shop on the church premises depending on availability.

- 18.2 The Co-ordinator/s/s further confirms that in the event of any loss arising from whatever cause including but not limited to loss of money or property in the possession of the Co-ordinator/s, the Co-ordinator/s/s hereby absolves SCOAN/Emmanuel TV from any liability arising therefrom and undertakes to take full responsibility of the aforesaid loss.
